
**Government Order**

- e) He will be accompanied along with his wife Ms. Rawnak Ara Khanom. She will stay in Dusseldorf, Germany till 05.12.2019. She will start for London, UK on 05.12.2019 and will stay there till 05.01.2020. Later on she will return to Dusseldorf, Germany on 05.01.2020 and will stay there till 21.02.2020. She will return to Bangladesh on 21.02.2020. All expenses regarding the travel of his wife will be borne by himself.

2. This G.O. is issued with the approval of the competent authority.


