# CONCEPT NOTE

### I. BACKGROUND

The Seventeenth Meeting of the Governing Board of SAARC TB and HIV/AIDS Centre, 27-28 November, 2007 recommended for establishing a SAARC Award on TB and HIV/AIDS for advocacy, commitment and recognition for exemplary work in the field of TB and HIV/AIDS in the region. The proposal of the Board for establishing the Award was approved by the Thirty First Session of the Programming Committee, 3-4 December, 2007. The GUIDELINES/ CRITERIA FOR CONFERMENT OF REGIONAL CENTRE'S PRIZE APPROVED BY THE THIRTY-SIXTH SESSION OF THE PROGRAMMING COMMITTEE (KATHMANDU 10-11 AUGUST 2009) which were approved during the Sixteenth SAARC Summit, held in Thimpu in 2010.

- 2. The Twentieth Meeting of the Governing Board of the SAARC Tuberculosis and HIV/AIDS Centre (23-24 September, 2010) recommended the SAARC Prize on TB and HIV/AIDS along with Concept Note. On the recommendation of Thirty-ninth Session of the Programming Committee (15-16 December, 2010) the Twenty-third Session of the Council of Ministers (Thimphu, 8-9 February, 2011) endorsed the Concept Note for the SAARC Prize on Tuberculosis/HIV/AIDS.
- 3. Considering the existing guidelines on the SAARC Prizes under the SAARC Regional Centres, the Twenty-first Meeting of the Governing Board of STAC also recommended for conferment of SAARC Prize on TB and HIV/AIDS alternatively each year and same was approved by the Forty-ninth session of the Standing Committee (Addu City, 708 Nov. 2011) as recommended by the Forty-first Session of Programme Committee (Kathmandu, 17-19 October, 2011).
- 4. Due to non receiving of applications/nominations for SAARC Prize on Tuberculosis-2014, the Twenty-fourth Meeting of the Governing Board of STAC(Kathmandu,23-24 September, 2014) recommended that the SAARC Prize on TB should be continued in 2015, which has considered by the Forty-eighth Session of the Programming Committee (SAARC Secretariat, 26-28 October, 2014).

### II. AIM OF SAARC PRIZE ON TUBERCULOSIS

The aim of the Prize is to honour citizen's or organizations of South Asia for their exemplary work towards control and prevention of **Tuberculosis** in the SAARC Region.

### III. OBJECTIVES OF THE PIZE

- 1. To encourage individuals and organizations based in South Asia to undertake programmes and activities complementing and supplementing the efforts on TB Control.
- 2. To honour outstanding contributions and achievements of individuals/ organizations of the region in the fields of Tuberculosis.
- 3. To recognize any other outstanding achievements, not covered above, of individuals and organizations in the region whose work or contribution has benefited or inspired the country as well as the region.

### IV. THE CRITERIA

The Individuals or Institutions (public/private/NGOs) will be eligible for nomination for the SAARC Prize on Tuberculosis. The Prize shall be given to the individual/organization working/having worked in the following areas on Tuberculosis.

- 1. Clinical work/Patient care and support.
- 2. Advocacy, Communication and Social Mobilization.
- 3. Research Work
- 4. Diagnostic/Laboratory works/Innovations
- 5. Community empowerment
- 6. Public Partnership Mix
- 7. Human Resource Development
- 8. Any other important areas

### V. ELIGIBILITY

Following will be applicable for individual and organizations.

- 1. Minimum 5 years of works on the subject/s (Tuberculosis)
- 2. Having contributed through innovation or extra ordinary works done on the subject (Tuberculosis).

### VI. TERMS AND CONDITIONS

- 1. Nominations must be made on the prescribed Nomination Form and be supported by the relevant documents.
- 2. Applications may be submitted directly by nominee (individual/organization) or through nomination by a reputed organization/individual in the field of Tuberculosis.

- 3. The last date for receipt of nominations at the SAARC Tuberculosis and HIV/AIDS Centre, Kathmandu, Nepal will be four months from the date of issue of notification by the SAARC Secretariat.
- 4. Supporting documents not in English must have an authenticated translation in English.
- 5. The summaries of the nominated individuals and organizations' accomplishments/ contribution for which the Prize is recommended should be precise, factual and not more than ten pages. Nominations by e-mail, fax or any other electronic means will not be acceptable.
- 6. Nominations for Prize to the eligible person/organization shall be supported by the organizations/eminent persons of repute in the field of Tuberculosis.
- 7. Entries received after the deadline will not be considered.
- 8. Nominations found to contain false information will not be eligible for the Prize.

### VII. THE PRIZE

The total Prize shall be US\$ 2,000.00 (US dollar Two Thousand) and shall be presented by the Chairperson/Governing Board Member to the recipient from their respective country.

### IX. PROCEDURE FOR SELECTION

All the entries for the Prize will be directly submitted to the Director, SAARC Tuberculosis and HIV/AIDS Centre. Incomplete entries or those received after the due date will not be considered. The Internal Committee will judge each entry and based on evaluation, submit their list maximum of five recommended candidates/institutions for Prize to the Governing Board for finalization of the Prize Winner.
